The Transformation of Occupational Health and Safety Learning – Year in Review

Regulatory Landscape and Accountability

2018 was definitely a year of significant change in occupational health and safety across North America. In Canada, we faced a year of federal and provincial regulatory change along with some key introductions. Not only did our industries see a significant change to regulations federally and provincially, but incidents such as the tragedy involving the Humboldt Broncos also accelerated them. Some of the most transformational changes included the introduction and legalization of cannabis across Canada and implementation of new regulations such as Bill 30 in Alberta resulting in the additional focus on maintaining safe work environments for employees and employers. 2018 is also the year of transfer of accountability and consequences. Negligence by organizations and individuals meant being implicated and criminal law applied to them for the violations to workplace safety and personnel. Organizations paid fines, expensive ones at that.

Cannabis legalization and its impact on your workplace safety

Federal legislation and the legalization of recreational cannabis in Canada as of October 17, 2018, presented a new paradigm to the safety of workers and the public. The use of alcohol and drugs can have adverse effects in the workplace. Impairment and substance abuse of cannabis in many cases are already included in an organizations drug and alcohol policy. The effects and recognition of cannabis use are complex and vary significantly between individuals. This results in requiring employees and employers need to train and understand the complexity of this substance and its effects on workers. Employers must now deal with

the myriad of issues accompanying the legalization of recreational cannabis. As with alcohol and other drugs that cause impairment, employers can prohibit workplace use and possession of cannabis, as well as employees attending for work while impaired.

A key concern for employers relating to the legalization of cannabis is workplace safety and potential liability if reasonable steps are not taken to address cannabis in the workplace. While it remains a sensitive issue, random drug and alcohol testing may become more common for employers with workers in safety-sensitive positions. In November, nearly seven years after its random testing policy was first rolled out, Suncor has reached an agreement with Unifor Local 707A to start random testing at its oil sands work sites in Alberta.

OH&S Changes and the impact in 2018

Bill 30: An Act to Protect the Health and Well-being of Working Albertans took effect on June 1, 2018. Amongst other changes, the bill repealed and replaced the Alberta Occupational Health and Safety Act.

Throughout 2018, multiple standards related to electrical safety were also updated (CSA Z462, CSA Z463 and IEEE 1584-2018).

On Dec. 14, 2017, Bill 177 introduced the most significant changes to Ontario's Occupational Health and Safety Act (OHSA) in nearly 30 years.

The WHMIS You Knew. The WHMIS You Want To Know.

The aftermath of the 1979 Mississauga derailment.

WHMIS has been with us since its introduction in 1988 and since then has gone through two revisions. The latest being the update that brings WHMIS into the 21st century.

WHMIS came into effect on October 1, 1988. The formation of WHMIS came out of the discussion regarding the Dangerous Goods Act in 1985 after the federal and provincial governments recognized the need for a national workplace hazard communication standard. The Mississauga train accident in 1979 in part prompted this.

The City of Mississauga was evacuated due to a train crash and led to the evacuation of all 225,000 residents. Luckily, there were no fatalities. The evacuation of the city was ordered as the train was carrying toxic gas, flammable gas, and liquid flammable materials. The ensuing explosion dispersed the toxic gas into the atmosphere before firefighters were able to contain the scene.

WHMIS training is now mandatory in workplaces and required by law to be taken. If you work with hazardous materials of any kind, then you've likely taken WHMIS at some point. If you haven't taken it in a long time and require a refresher or this is new to you, it's a great idea to take the award-winning WHMIS online or self-teach with Danatec.

Are You Ready for Cannabis in the Workplace?

The legalization of cannabis in Canada has added a new component to managing employees and safety in the workplace. Non-medicinal cannabis was legalized in October of 2018 and organizations are racing to catch up. According to a recent ongoing study by the Institute for Work & Health, there is a critical knowledge gap about the potential impact of legalization on productivity as well as health and safety in the workplace.

“Until now we really have lacked information on the extent of cannabis use,” says Nancy Carnide, part of the research team working on the study. “There is little information on how workers perceive cannabis use especially in regard to the workplace.”

Preliminary findings indicate that over 20 per cent of surveyed Canadian workers did not know if their workplace has a cannabis policy in place and 11 per cent were unsure if cannabis use was acceptable

within two hours of being at work, as reported by the Chartered Professional Accountants of Canada.

“We want to be able to see if workers perceive it as less risky at work and if so, that can influence behaviour.”

There is a lot of conversation in the employer community on how these changes will affect employee productivity and safety at work.

One of the easiest ways an organization can prepare for the changes the Canadian workplace is experiencing is to invest a few hours in getting trained. Danatec by Yardstick Training helps employers avoid confusion understanding cannabis legislation, saves them the time developing new cannabis policies and employee education, and perhaps most importantly, guides them on how to effectively communicate and manage workplace policies around cannabis use. Those in leadership positions and Human Resources should be

“The importance of having a workforce trained and knowledgeable about their rights and responsibilities around the usage of recreational or medical cannabis in the workplace is undeniable,” said Greg Britton, General Manager at Danatec by Yardstick Training. “This takes away the confusion and ambiguity of what is expected of an employee and employer and protects both from potential liability.”

This sentiment is echoed by Carnide, “The benefit of legalization in this particular context has been that it has started conversations between employers and employees about substance abuse, not just cannabis and impairment.”

“We hear anecdotally that workers are using cannabis, but we don’t have a sense of to what extent,” she adds.

Having those conversations helps make things more transparent and hopefully safer in the long run. Improving communication, having workplace policies in place, and training all employees and employers in cannabis safety will help build safer work environments and has become a key component of safety management in Canadian organizations.
