OCCUPATIONAL HEALTH AND SAFETY ACT

DUTIES IN RESPECT OF HEALTH AND SAFETY

Employer's duties

- 3(1) Every employer shall ensure, so far as is reasonably practicable, that
- (a) the workplace, machinery, equipment, and processes under the employer's control are safe and without risks to health;
- (b) work techniques and procedures are adopted and used that will prevent or reduce the risk of occupational illness and injury; and
- (c) workers are given necessary instruction and training and are adequately supervised, taking into account the nature

Constructor's duties

- 4 Every constructor shall ensure, so far as is reasonably practicable, that during the course of each project the constructor undertakes
- (a) the measures and procedures prescribed by this Act and the regulations are carried out on the project;
- (b) every employer and every person working on the project complies with this Act and the regulations; and
- (c) the health and safety of workers on the project is protected. S.Y. 2002, c.159, s.4

Employee's duties

- 9 Every worker shall, so far as is reasonably practicable, in the course of their employment
- (a) take all necessary precautions to ensure their own health and safety and that of any other person in the workplace;
- (b) at all appropriate times use the safety devices and wear the safety clothing or equipment provided by the employer or required under this Act to be used or worn;
- (c) comply with health and safety procedures and with instructions given for their own or any other person's health or safety by a person having authority over them;
- (d) report immediately to their immediate supervisor any situation which they have reason to believe would present a hazard and which they cannot correct; and
- (e) report any accident or injury that arises in the course of or in connection with their work. S.Y. 2002, c.159, s.9

HAZARDOUS WORK

Refusal by employee

- 15(1) A worker may refuse to work or do particular work if the worker has reason to believe that
- (a) the use or operation of a machine, device, or thing constitutes an undue hazard to that worker or any other person; or
- (b) a condition exists in the workplace that constitutes an undue hazard.

REGULATIONS

Elevated and self- propelled platforms Standards

- 10.32 An elevating work platform shall be designed, constructed, erected, maintained, inspected, monitored and used in accordance with the following standards:
- (a) CSA B354.1-M82, Elevating Rolling Work Platforms,
- (b) CSA B354.2-M82, Self-Propelled Elevating Work Platforms for Use on Paved/Slab Surfaces,
- (c) CSA B354.3-M82, Self-Propelled Elevating Work Platforms for Use as 'Off-Slab' Units,
- (d) CSA B354.4-M82, Boom-Type Elevating Work Platforms, or
- (e) other similar standards acceptable to the director.
